THE 55,678 ACRE DOWNEAST LAKES COMMUNITY FOREST IS MANAGED FOR WILDLIFE HABITAT, SUSTAINABLE TIMBER HARVEST, AND PUBLIC RECREATIONAL ACCESS. DLLT HOLDS AN INDEPENDENT THIRD PARTY FOREST MANAGEMENT CERTIFICATION. WILDLIFE HABITAT AND TIMBER MANAGEMENT ARE INTEGRATED TO MAINTAIN HABITATS FOR THE FULL RANGE OF NATIVE WILDLIFE ON A LANDSCAPE SCALE. DLLT HAS IMPROVED RECREATIONAL ACCESS BY MAINTAINING FOREST ROADS, ESTABLISHING AND MAINTAINING SEVEN HIKING TRAILS AND THE DOWNEAST LAKES WATER TRAIL. DLLT TIMBER HARVESTS SUPPORT THE LOCAL ECONOMY, WHILE WILDLIFE HABITAT AND RECREATIONAL ACCESS IMPROVEMENTS SUPPORT NATURE BASED TOURISM BUSINESSES, INCLUDING SPORTING LODGES AND GUIDES.
